Acknowledgement of Inherent Risk, Waiver and Release, and IndemnificationAgreement

- 1. I acknowledge and understand that there are inherent risks associated with participating in the Young Life Mobile 5K Run/Walk Family Cookout/Crawfish Boil (hereinafter "the Event") that will be held for the benefit of Young Life Mobile on April 26, 2015, including, but not limited to, those caused by terrain, facilities, temperature, weather, conditions of the athletes, equipment, vehicular traffic, actions of other people, including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. I will assume all of the risks associated therewith, whether known or unknown to me at this time. I acknowledge and certify that I am fit to run and/or walk in this event, have sufficiently trained for participation in this event and have not been advised otherwise by a qualified medical person. I hereby consent to medical treatment which may be deemed advisable in the event of injury, accident and/or illness during the Event.
- In consideration of permitting me to participate in the Event, I release the following entities and/or persons and their directors, officers, employees, and agents from responsibility for my accidental physical injury, including death or illness, and loss of, or damage to, personal property while participating in this race: Young Life, LRH Productions, and any other event holders, sponsors, directors and volunteers. This release is also intended to include all claims made by my family, estate, heirs, personal representative or assigns. I acknowledge and certify that I will indemnify and hold harmless the entities and/or persons mentioned in this paragraph from any and all liability and/or claims made by other individuals and/or entities as a result of my actions during the Event.
- 3. I understand that bicycles, skateboards, roller skates or blades, are prohibited in the Event, and I agree to abide by this rule.
