**Distances:** Certified 8K (AL25029JE) course through Saraland residential neighborhoods surrounding Amelia Park. The course is mostly flat with some gentle inclines. Water provided along the course. Fun Run is approximately 1 Mile.

**Registration:** Pre-register by mail (entries should be postmarked by April 10), in person at McCoy Outdoor, Run-N-Tri, or Fleet Feet in Mobile until noon on April 16 or online on [events.com](http://events.com) until 6 AM on April 17. Early packet pick-up and late registration will be available on Friday, April 17, from noon to 5:30 PM at the Port City Pacers office (358 Morgan Ave., Mobile, AL). Race day registration is at the Amelia Park Pavilion from 6:30-7:45 AM.
